## WAITING LIST AND CRITERIA

#### **Waiting list**

In order to be placed on the waiting list, persons in need of rehabilitation can fill out the 'Insertion Request Form' going to the secretariat of the 'Association Scuola Viva'. The form can also be filled in by telephone or online through www.scuolaviva.org.

Requests for inclusion are registered on the waiting list in chronological order and can only be confirmed upon presentation of a suitable specialist prescription or multidimensional assessment by the ASL, according to the specific services.

The waiting list is splitted by the following types:

#### **Semi-Residential**

#### Non Residential:

- Outpatient Developmental Age
- Motor, Neuromotor and Vascular Outpatient Rehabilitation
- Motor and Neuromotor Home Rehabilitation

#### **Evaluation and Priority Criteria**

Requests for treatment are assessed by the Doctor, the Coordinator and the Social Worker of Scuola Viva, according to the listed order and the specialist prescription or the multidimensional assessment by the ASL. Other items have to be taken into consideration, such as the severity of illness, the urgency of the treatment itself and compliance with the clinical access criteria defined by the Regional regulations.

The evaluation of a new user will begin when there are vacancies or when a user is expected to be discharged and/or if the rehabilitation project is stopped without warning.

After the first medical test, once eligible for inclusion, the waiting time before starting the rehabilitation project, will be notified within 15 days.

# CHARGES PAYABLE BY THE USER

For both the Semi-Residential Dept extensive rehabilitation projects mode and the Non-Residential Outpatient and Home Care Sector, the entire charge is borne by the National Health Service.

For the socio-rehabilitation (maintenance) projects mode in the Semi-Residential Dept, the user charges are set at 30% of the fee, according to the Region Lazio Resolution income brackets no. 790 of 20/12/2016 ex D.G.R. no. 380 of 07/08/2010.

#### WHERE ARE WE

The Centre is located in Via Crespina no. 35 - 00146 Rome, within a large green area and has several parking areas.

Doctors' offices and gyms are located in Via Crespina no. 30 accessing from Vicolo Pian Due Torri on Via Pescaglia side, where there are additional parking areas.

#### HOW TO GET THERE

- by their own means:

Private parking, Via Crespina 30

**P**rivate parking, Vicolo Pian Due Torri (drive along Via Pescaglia, cross the cycle path, turn left and after the downhill slope turn right)

- bus:

**780**, **781** and **128** stop Via della Magliana (height Via Pian Due Torri) then walk 1,300 metres (entrance from Via Crespina 35)

- railway:

FS Villa Bonelli then on foot for 1000 m (entrance from Via Pescaglia → Vicolo Pian due Torri)

The Centre works daily except on holidays, as follows:

## The Centre:

Monday to Friday from 08.20 a.m. to 07.30 p.m. Saturday from 08.30 a.m. to 12.30 p.m.

# The Secretariat:

Monday to Friday from 08.30 a.m. to 04.30 p.m.

#### REHABILITATION TREATMENTS TYPES

The person is taken in charge by the multidisciplinary team, consisting of: doctors, psychologists, rehabilitation professionals and the social worker.

## **SEMI-RESIDENTIAL**

The Semi-residential Dept is addressed to **young adults with intellectual and developmental disabilities**, due to, for example, genetic diseases and/or trauma and/or related to pervasive developmental disorders.

The Semi-residential Dept is specialised in educational rehabilitation projects based on group or individual activities, enabling users, with different learning abilities to relate, understand and improve their personal autonomy and self-esteem, to prevent worsening and in order to foster social participation.

The Semi-residential service is provided by the Centre in Via Crespina 35, through rehabilitation-education treatment for 36 (thirty-six) hours weekly spread over five days. Transport of users to and from the Centre is organised by the Local Health Authority or by the users' family members.

# **NON RESIDENTIAL**

# OUTPATIENT REHABILITATION SERVICE FOR CHILDHOOD AGE

This service is aimed to users with disorders in the area of neuro-development. Particularly, as follows: communication disorders (speech, social-pragmatic communication), movement disorders (motor coordination), specific learning disorder, intellectual disabilities and mixed developmental disorder, autism spectrum disorders, hearing loss, P.C.I. outcomes, attention-deficit/hyperactivity disorder, neuromotor disorders.

According to specific needs, the project is given by speech therapy, neuro-psychomotricity, physiotherapy, educational interventions and Interventions with Animal.

## NON RESIDENTIAL

# MOTOR, NEUROMOTOR AND VASCULAR REHABILITATION SERVICES

These services are provided to persons with disabilities due to complex diseases affecting the osteoarticular, the neuro-muscular and the lymphatic systems.

Neurological rehabilitation service is aimed to people with a loss of autonomy due to congenital or acquired diseases of the central and/or peripheral nervous system. For example: Parkinson's disease and Parkinsonism, ataxias, multiple sclerosis, ALS, dystrophies, tetraplegia paraplegia, haemiplegia, monoplegia from ischaemic or haemorrhagic stroke outcomes, post-cancer or post-surgical disabilities.

The <u>orthopaedic rehabilitation</u> service is aimed to people with disabilities following a major acute or chronic impairment of the musculo-skeletal system and post-surgical conditions. For example: joint replacement outcomes (hip, knee, shoulder), limb amputations, osteo-articular polytrauma, tendon and muscle injuries, rheumatoid arthritis.

<u>Vascular rehabilitation</u> service is aimed to people with disorders of the vascular, lymphatic or venous system, such as: <u>post-mastectomy lymphoedemas</u> and <u>other lymphedemas</u>.

## Outpatient rehabilitation treatment

Rehabilitation treatment is carried out in the Centre's facilities, within the gyms equipped with special instruments.

#### Home rehabilitation treatment

Home treatments are provided to support special needs, such as:

- user inable to reach the outpatient services due to severe disabilities,
- carry out a readaptation programme within the home environment and in daily activities.
